- Constitutional Amendment approved on first consideration on May 17<sup>th</sup> Senate passed 26-6, Assembly 82-11
- Must be considered and adopted again in 2013 legislative session.

- DOA released General Fund Tax Estimates on May 10<sup>th</sup>
  - \$265 million re-estimate above LFB February report
- Previous LFB report on February 9<sup>th</sup> differed
  - \$11 million balance for 2011-12
  - Shortfall of \$143 million projected for 2012-13
